TUITION FEES FOR 2010-2011 SCHOOL YEAR

Tuition can be paid in full at registration and you will receive a 5% discount on the total tuition or it can be paid in ten months with even payments. The first payment is due at registration in August and the last payment is May.

REGISTRATION FEE - \$70

A \$70 registration fee is due with the application. This fee is non-refundable. *Those who paid the pre-registration fee do not need to pay this fee at registration.*

ACTIVITY FEE - \$50

An activity fee of \$50 per child is due at registration. This fee covers their school yearbook and helps pay for class projects, supplies, parties and some fees for field trips.

KINDERGARTEN & FIRST GRADE SUPPLY FEE - \$25

The Kindergarten and first grade teachers supply all of the items needed for the children to accomplish their activities during the year. To cover these expenses the parents pay a \$25 supplies fee at registration.

HOT LUNCH TICKETS - \$3 per meal

Parents may purchase hot lunch tickets in advance in increments of \$30 or \$60. The teachers keep the tickets and punch them when a child eats hot lunch. Tickets may be purchased at the school office. Please purchase a ticket for your child if they plan on eating several times a week. **We do not want to keep track of IOU's.**

WORTHY STUDENT

There may be some money available to families who cannot make the full payment for tuition. Ask the principal for the possibility of receiving help from this fund sponsored by local Seventh-day Adventist churches.

FAMILY NEED SCHOLARSHIP – S.E.C.C. OF S.D.A.'S

This is available to families of a constituent church whose adjusted family income is **at or below \$33,241**. The adjusted family income is figured out by **taking the income from your income tax and subtracting \$3,600 for each child in the family**. **Please give the principal a copy of the front of your Federal Income Tax Form that states your income for last year if you qualify for this scholarship. This scholarship has a deadline. Turn in a copy of the front page of your tax form immediately if you qualify.**
